REGISTRATION

CAMP FACILITIES

All camp sessions take place on the campus of Culver-Stockton College. The majority of the camp will take place at Ellison Poulton Stadium or on the practice football fields.

INSURANCE AND MEDICAL CARE

The Wildcat football camp will NOT be responsible for any medical or other medically-related charges in connection with a camper's attendance. Each camper's parent or legal guardian will be required to authorize a medical release form that releases the camp, and its directors and employees, from ALL liability for injuries, accidents and/or illness incurred while at camp. No refunds will be made after July 23, 2011. Any camper leaving camp due to injury will receive a prorated credit good for use at a future camp.

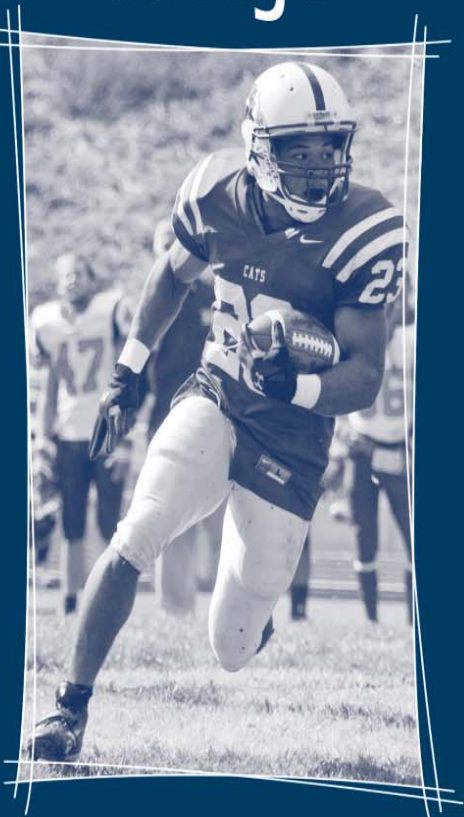
